## **PRIVACY NOTICE**

At FXLINK Corporation, we are committed to maintaining the highest standards of integrity. In the course of our business, it is necessary to collect Personal Information about our potential clients. We take this activity seriously and seek to provide fair, secure and appropriate methods for the handling of Personal Information. All such activities are intended to be consistent with both generally accepted privacy ethics and standard business practices. Your Personal Information may be shared with a limited number of trusted partners and/or affiliates of FXLINK for the purposes of providing financial services.

## **PERSONALLY IDENTIFIABLE INFORMATION**

FXLINK Corporation shall process your personal data as a Data Processor when you specifically opt-in and provide us with your consent, during your application to open a Metatrader 5 account. FXLINK Corporation has a lawful base for processing your data, and it is for the following reason; 'processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into the contract.'

If you open an FXLINK Corporation Metatrader 5 account, you will be asked for information regarding your name and address, employment and salary details. As part of the Money Laundering Regulations 2021, and FXLINK Corporation's regulatory requirements with the National Futures Association (NFA), we are required to establish proof of your identity and address during the onboarding stage. This process is conducted mainly by FXLINK Corporation by requesting, and processing copies of your personal identifiable information, but also involves the use of third parties who conduct electronic verifications on our behalf. You might be asked to supply additional information to support any unsuccessful verification attempts.

Where stated we may use the personal information you provide to contact you in the future about FXLINK Corporation products and services. We only hold data which is necessary to offer the services provided on our website.



### ***THIRD PARTY SITES***

This website contains links to other websites. Please note that FXLINK Corporation cannot be held responsible for the privacy policies of other websites. We encourage all visitors to be aware and read the privacy statements of every website that collects personally identifiable information. FXLINK Corporation can confirm that it has a strict policy of not sharing your Personal Identifiable Information with an unauthorized third party under any circumstances.

### ***PRIVACY STATEMENT CHANGES***

FXLINK Corporation may change this privacy statement at any time. If a change does occur, you will be notified accordingly, and where applicable your consent would be required. You are advised to read the statements so that you are satisfied with the privacy conditions under which you provide FXLINK Corporation with your personal information.

### ***EU GENERAL DATA PROTECTION REGULATION (GDPR)***

FXLINK Corporation as a Data Controller and Processor is bound to comply with the requirements and principles of GDPR in controlling and processing your personal identifiable information. FXLINK Corporation is registered with the Information Commissioner's Office (ICO), who is the UK's independent authority set up to uphold information rights in the public interest, promoting openness by public bodies and data privacy for individuals.



## ***RETENTION OF RECORDS***

We will keep Personal Information only as long as it is necessary and required to do so subject to NFA regulation, including for the purposes of updating the product or services or as required by law. The retention period of your personal identifiable information is for a minimum of 5 years. You have a right to request to erase your information, however this is subject to the 5-year retention period mentioned above.

When the Personal Information is no longer required, it will be destroyed either by shredding or other approved destruction methods to prevent unauthorized parties from gaining access to the information during and after the process.

## ***YOUR RIGHTS***

The GDPR provides the following rights for individuals:

1. The right to be informed
2. The right of access
3. The right to rectification
4. The right to erasure
5. The right to restrict processing
6. The right to data portability
7. The right to object
8. Rights in relation to automated decision making and profiling.

## ***WE WILL SAFEGUARD INFORMATION IN OUR CUSTODY***

We have developed and will maintain security procedures to safeguard Personal Information against loss, theft, copying, and unauthorised disclosure, use or modification. Access to Personal Information is restricted to employees and authorised service providers who need it to perform their work.



## ***RIGHT TO WITHDRAW CONSENT***

You have the right to withdraw your consent at any time, subject to meeting one of the following conditions:

1. Your personal identifiable information to which has been processed by FXLINK Corporation has surpassed the 5-year retention period;
2. You do not have an open MetaTrader 5 account; or
3. You failed to open an MetaTrader 5 account (for example due to being refused during the application stage).

If you meet one of the above conditions, you may contact us at any time and withdraw your consent.

## ***RIGHT TO LODGE A COMPLAINT***

You retain the right to lodge a complaint with the ICO if you believe or consider that the processing of your personal identifiable data by FXLINK Corporation infringes the key principles of GDPR. We have provided a link to the ICO's website for their contact details.

How is your Personal Information collected by our website?

Personal Information may be submitted to both the public and private areas of our website.

Personal Information may be submitted on our website in two areas:

**1. Public Area**

If you do provide your name and address on the public area of this website in order to request information about our products and services, you may voluntarily provide additional personal information. You will be asked to provide your Personal Information in this area for the purposes of registering with FXLINK Corporation and opening an account with us.

**2. Private Area**

To ensure a good quality of service we may monitor and record any communication you have with us whether in writing, by phone or by electronic mail. E-mail is not encrypted to / from either the public or private areas of this website. FXLINK Corporation recommends that you do not send us Personal Information by e-mail.

***SESSION COOKIES***

We use session cookies for the following purposes:

- To allow you to carry information across pages of our site and avoid having to re-enter information.
- Within registration to allow you to access stored information.
- Non personal data for tagging purposes only (by random number).



## ***PERSISTENT COOKIES***

We use persistent cookies for the following purposes:

- To help us recognise you as a unique visitor (just a number) when you return to our website and to allow us to tailor content or advertisements to match your preferred interests or to avoid showing you the same adverts repeatedly.
- To compile anonymous, aggregated statistics that allow us to understand how users use our site and to help us improve the structure of our website.
- To internally identify you by account name, name, email address, customer ID, currency and location (geographic and computer ID/IP address).
- To differentiate users who are on the same network to enable us to correctly allocate bets to the appropriate account.
- Within research surveys to ensure you are not invited to complete a questionnaire too often or after you have already done so.

## ***THIRD PARTY COOKIES***

Third parties serve cookies via this site. These are used for the following purposes:

- To serve advertisements on our site and track whether these advertisements are clicked on by users.
- To control how often you are shown a particular advertisement.
- To tailor content to your preferences.
- To count the number of anonymous users of our site.
- For website usage analysis.



## ***USE OF WEB BEACONS***

Some of our Web pages may contain electronic images known as Web beacons (sometimes known as clear gifs) that allow us to count users who have visited these pages. Web beacons collect only limited information which including a cookie number, time and date of a page view, and a description of the page on which the Web beacon resides. We may also carry web beacons placed by third party advertisers. These beacons do not carry any personally identifiable information and are only used to track the effectiveness of a particular campaign.
